DGCA Extends License of Maharishi Valmiki International Airport


The DGCA issued an aerodrome license for Maharishi Valmiki International Airport Ayodhya Dham, developed at a cost of ₹350 crore. The airport features a 2,200m runway with AGL infrastructure, DVOR, and ILS for night and low-visibility operations. It includes a 6,500 sqm terminal, accommodating 600 passengers during peak hours and 10 lakh annually. IndiGo will start flights from Delhi to Ayodhya on December 30, with commercial operations beginning January 6, 2024.

India Ranks 63rd in Global Energy Transition Index

India has been ranked 63rd on the World Economic Forum's Global Energy Transition Index, showing significant improvements in energy equity, security, and sustainability. European countries dominated the top ranks, with Sweden leading, followed by Denmark, Finland, Switzerland, and France. China was ranked 20th. Despite the global slowdown in energy transition progress, India and China have shown advancements in renewable energy, energy access, and security.



NSE Unveils Nifty India Tourism Index

NSE Indices Limited launched the Nifty India Tourism Index to track the performance of travel and tourism-related stocks from the Nifty 500 Index. This initiative aligns with the Indian government's efforts to boost tourism and its contribution to GDP, which stands at approximately \$199.6 billion. The index, with a base date of April 1, 2005, and a base value of 1000, will be reconstituted semi-annually and rebalanced quarterly, serving as a benchmark for asset managers and passive funds.


Grandmaster Arjun Erigaisi Claims Stepan Avagyan Memorial 2024 Title

GM Arjun Erigaisi of India dominated the Stepan Avagyan Memorial 2024 in Jermuk, Armenia, winning with a round to spare. He secured victory with 6 points after defeating Volodar Murzin of Russia. Arjun's strong performance included four wins and four draws, earning him 9 Elo rating points and boosting his live rating to 2779.9. His success places him fourth globally, trailing only Magnus Carlsen, Hikaru Nakamura, and Fabiano Caruana.

Tajikistan's parliament has passed a bill, now awaiting approval by the president, to officially ban "alien garments" including the hijab, citing amendments to administrative laws. This move extends previous unofficial bans on Islamic attire and mandates fines for violations. The legislation also prohibits children from celebrating Eid al-Fitr and Eid al-Adha in public, reflecting ongoing cultural and religious restrictions in the Central Asian nation.



Discovery of Protein Balon in Bacterial Dormancy


Scientists recently discovered Balon, a protein in Psychrobacter urativorans, which halts protein production by binding to ribosomal active sites during adverse conditions, like cold shocks. Unlike other proteins, Balon allows rapid recovery of protein synthesis when conditions improve. Published in Nature, this finding sheds light on bacterial survival mechanisms in extreme environments, including implications for food spoilage and potential applications in industry and environmental control.

Government Monetises ₹1.56 Lakh Crore in FY24

In the fiscal year 2023-24, the Indian government achieved asset monetisation worth ₹1.56 lakh crore under the National Monetisation Pipeline (NMP), slightly below its ₹1.8 lakh crore target. This initiative aims to leverage private sector investment for infrastructure development, with key sectors like roads, coal, and power contributing significant amounts. NHAI has identified 33 assets for monetisation in 2024-25 to expedite further infrastructure creation through private investments.
