
Pankaj Advani Clinches 2025 Asian Snooker Championship Title

Indian cueist Pankaj Advani clinched the 2025 Asian Snooker Championship men's title by defeating Iran's Amir Sarkosh 4-1 in the final, marking his 14th Asian title across snooker and billiards. The event, held in Doha, Qatar, from February 15-21, was organized by the Asian Confederation of Billiards Sports (ACBS). Mongolia's Narantuya Bayarsaikhan won the women's title, while Iran's Shaheen Sabzi secured the men's U-21 crown. ACBS, founded in 1984, governs non-professional billiards and snooker in Asia.

PNB Collaborates with ITBP to Offer Exclusive Banking Benefits





SEBI Imposes Rs 5 Crore Penalty on BSE's ICCL for Regulatory Breaches

SEBI imposed a Rs 5.05 crore penalty on the Indian Clearing Corporation Ltd. (ICCL), a subsidiary of BSE Ltd., for violations of cybersecurity, IT asset management, and disaster recovery protocols. SEBI found that ICCL failed to maintain an updated inventory of critical IT assets, delayed addressing audit issues, and had deficiencies in its disaster recovery systems. Despite ICCL's defense that the lapses were technical and did not harm investors, SEBI deemed the violations serious, leading to the financial penalty.

NASA and SpaceX are teaming up to launch the Athena mission to the Moon

Intuitive Machines' Athena mission, set for launch on February 26, 2025, aims to explore the Moon's south pole. Launched by SpaceX's Falcon 9, Athena will study lunar soil composition, search for subsurface water, and test Nokia's 4G communication system. The lander will deploy rovers and a hopping drone for terrain analysis. Targeted for Mons Mouton, the mission includes several scientific payloads, including the MAPP Rover and Lunar Trailblazer satellite, and is part of NASA's CLPS program.

Unilever's CEO, Hein Schumacher, has announced his resignation

Unilever announced that CEO Hein Schumacher will step down by March 2025, with Fernando Fernandez, the current CFO, set to take over. Schumacher, who joined in July 2023, leaves after successfully implementing the Growth Action Plan (GAP) and driving financial progress. Fernandez, appointed CFO in January 2024, previously led Unilever's Beauty & Wellbeing business. Ian Meakins, Unilever's Chairman, praised Schumacher's leadership, highlighting significant strategic achievements. Following the transition, Srinivas Phatak will become the acting CFO.


