
Centre Announces 24% Increase in Salaries and Pensions for MPs

The Central government has announced a 24% salary hike for Members of Parliament (MPs), raising their monthly salary from Rs 1,00,000 to Rs 1,24,000. The revision, issued by the Ministry of Parliamentary Affairs, also increases the daily allowance from Rs 2,000 to Rs 2,500 and raises pensions for former MPs. Additionally, Karnataka's state government has approved a 100% salary hike for the Chief Minister, ministers, and MLAs. These revisions were made under the Salary, Allowances, and Pension of Members of Parliament Act, considering inflation adjustments.

The Archaeological Survey of India (ASI) has uncovered over 110 megalithic structures near Malampuzha Dam in Kerala and significant Buddhist artifacts in Ratnagiri, Odisha. The Kerala discovery includes Neolithic and Bronze Age burial sites, featuring cists, dolmens, and stone circles made of granite and laterite. Meanwhile, the Ratnagiri excavation has revealed colossal Buddha heads, a brick stupa, a chaitya complex, and numerous votive stupas with Sanskrit inscriptions. These findings highlight India's rich historical and cultural heritage spanning different eras.

Delhi Budget for 2025-26

Delhi Chief Minister Rekha Gupta presented the BJP-led government's first budget for the national capital, totaling Rs 1 lakh crore—a 31.5% increase from the previous year. Key allocations include Rs 28,000 crore for capital expenditure, Rs 5,100 crore for the Mahila Samridhi Yojana, Rs 9,000 crore for clean water, and Rs 12,952 crore for transport. Other initiatives include CCTV installation, free laptops for students, and slum development. The budget also earmarks funds for Yamuna cleaning, Atal Canteens, and an International Film Festival, aiming for infrastructure and social welfare improvements.

India's GDP Doubles Over the Past Decade


India's GDP has doubled in the past decade, growing from 2.1 trillion dollars in 2015 to 4.3 trillion dollars in 2025, marking a 105% increase, according to IMF data. This growth surpasses major economies like the U.S. (66%) and China (44%). Now the world's fifth-largest economy, India is set to surpass Japan soon. BJP Minister Amit Malviya credited PM Modi's leadership, citing economic policies, structural reforms, and business-friendly initiatives as key drivers of India's rapid growth and global economic rise.


