
Rahul Bhave has been appointed as the Managing Director and CEO of IFCI.

Rahul Bhave has been appointed as the Managing Director and CEO of IFCI for a three-year term. Previously serving as Deputy MD, his appointment was approved by the Appointments Committee of the Cabinet. IFCI, India's first development financial institution, was established in 1948. The government has also approved the consolidation of the IFCI Group, merging various subsidiaries like StockHolding Corporation of India Ltd, IFCI Factors Ltd, and others into a unified entity to enhance operational efficiency and streamline management.

West Bengal Police introduces a mobile app to ensure transparent transfers

The West Bengal Police have launched a mobile app to ensure transparency in transfer postings, addressing complaints of bribery. The app, part of the e-HRMS software, allows personnel from constable to sub-inspector ranks to apply for transfers, with a deadline of April 11. Special medical cases can apply throughout the year. Previous applicants must reapply through the software. Help desks will assist personnel in using the app. This initiative follows a similar move for teachers with the 'Utsasree' app.

B Sumeeth Reddy Retires from Badminton to Pursue a Coaching Career



Initially a singles player, he transitioned to doubles after a spinal condition threatened his career. Partnering Manu Attri, he reached a career-high world ranking of 17 in men's doubles and won multiple international titles. Before retiring, he was ranked 25th in mixed doubles with his wife, N Sikki Reddy. Now part of India's national coaching setup, he aims to strengthen Indian badminton.

Haryana Chief Minister Nayab Singh Saini has launched the AI-powered chatbot, Sarathi to enhance citizen engagement. It processes over 17,820 official documents and 73,622 scanned PDF pages. The initiative aims to improve governance efficiency and accessibility. 
The Reserve Bank of India (RBI) has revised Priority Sector Lending (PSL) guidelines, effective April 1, 2025, to enhance credit targeting for key sectors. The changes include increased loan limits for housing and renewable energy projects, a higher PSL target of 60% for urban cooperative banks, and expanded eligibility for 'Weaker Sections.' Additionally, the cap on loans to individual women beneficiaries by UCBs has been removed. These updates aim to improve financial inclusion and support economic growth across priority sectors.

Baalpan Ki Kavita Initiative, Reviving Traditional Indian Rhymes for Young Children

The Union Education Ministry has launched the "Baalpan ki Kavita" initiative to compile nursery rhymes and poems in Indian languages and English, focusing on culturally relevant content. The initiative aims to enhance early childhood learning by providing joyful and relatable poems in children's mother tongues. In collaboration with MyGov, the ministry invites submissions of existing, folklore-based, or newly composed rhymes under three categories. This effort seeks to preserve India's linguistic heritage and improve foundational education through engaging literature.

ATM Withdrawals to Become More Expensive from May 1 as RBI Approves Fee Increase

From May 1, ATM withdrawals will become costlier as the RBI raises interchange fees. Customers exceeding their free transaction limits (five in metro cities, three in non-metro areas) must pay Rs 19 per transaction, up from Rs 17. Non-transaction charges, including balance inquiries, have also increased. Banks are updating minimum balance requirements, with penalties for non-compliance. Credit card perks are being revised by major banks. The changes follow requests from ATM operators citing rising costs, impacting smaller banks relying on larger institutions.
