Shardul Thakur Leads the Wicket-Takers List as the Purple Cap Holder in IPL 2025



Digital Crop Survey (DCS) System

The Ministry of Agriculture and Farmers Welfare has launched the Digital Crop Survey (DCS) System to collect real-time crop data using a mobile interface. This initiative ensures precise crop area estimation and supports accurate production forecasts. Integrated with Agri Stack, the system prioritizes data privacy under the Digital Personal Data Protection Act, 2023. Secure APIs, encryption, and regular audits safeguard farmers' information. To promote digital inclusion, states facilitate participation through Farmer Producer Organizations (FPOs) and Common Service Centres (CSCs).




Government Discontinues Gold Monetisation Scheme

The Indian government has discontinued the Gold Monetisation Scheme (GMS), except for short-term bank deposits, citing evolving market conditions. Launched in 2015, GMS aimed to mobilize idle gold and reduce imports. It had three deposit categories: short-term (1-3 years), medium-term (5-7 years), and long-term (12-15 years). The RBI clarified that existing deposits will remain valid until maturity. The decision follows the earlier discontinuation of sovereign gold bonds, aligning with rising gold prices and a shift in government strategy.

The Indian government plans to borrow Rs 8 lakh crore in H1 FY26, constituting 54% of the total Rs 14.82 lakh crore annual target. The borrowings will be through securities of varying tenures, with 65% allocated to those up to 15 years. Additionally, Rs 10,000 crore will be raised via Sovereign Green Bonds. Weekly Treasury Bill issuances will total Rs 19,000 crore. The RBI has set the WMA limit at Rs 1.50 lakh crore. The fiscal deficit target for FY26 is 4.4%, down from 4.8% in FY25.

The National Technical Textiles Mission (NTTM), launched in 2020 with a budget of Rs 1,480 crore, aims to boost India's technical textiles sector through research, market growth, exports, and skill development. It has supported 168 research projects worth Rs 509 crore and seeks to train 50,000 individuals. Key initiatives include GIST 2.0 for industry-academia collaboration and the GREAT scheme for startup funding. Events like Technotex 2024 showcase innovations, driving India's ambition to become a global leader in technical textiles.

Thailand PM Declares State of Emergency Following Myanmar Earthquake


A powerful 7.7-magnitude earthquake struck Myanmar on March 28, 2025, with tremors felt in Thailand, causing severe damage. At least 25 people died in Myanmar, and an under-construction building collapsed in Bangkok, leaving 43 missing and 3 dead. Myanmar's military junta declared an emergency and sought international aid. Thailand also declared an emergency, with Bangkok as a disaster zone. The Ava Bridge collapsed in Myanmar, and Mandalay University was damaged. India and other countries are monitoring the situation and offering assistance.

The Khelo India Para Games 2025 have come to a close

The second Khelo India Para Games (KIPG) 2025 concluded in Delhi on March 27. Powerlifters from SAI Gandhinagar dominated the competition, securing 10 medals, including 7 golds. Athletes like Jhandu Kumar, Jaspreet Kaur, Seema Rani, and Manish Kumar set national records, with some breaking their own previous records. The center's facilities have grown significantly since 2016, with plans to target 3-4 medals at the World Championships in Egypt. SAI Gandhinagar aims to produce future Paralympic champions.

In 2024, India emerged as the world's second-largest tea exporter.

India has become the world's second-largest tea exporter in 2024, surpassing Sri Lanka with a record export of 255 million kg, according to Tea Board of India data. This marks a 10% increase from 2023. Despite consuming 80% of its tea production, India remains a top global exporter. The country's tea exports, valued at Rs 7,111 crores, have grown, driven by demand from markets like Iraq, UAE, and Russia. The government is supporting small tea growers and workers, strengthening the industry's supply chain.


