- Free Coaching from Empaneled Institutes: Eligible students can receive free coaching from specific coaching institutes that have been empaneled under the scheme. These empaneled institutes must enroll students based on their fulfillment of eligibility criteria and seat availability.
- Fee Reimbursement for Non-Empaneled Institutes: In cases where students wish to join coaching institutes not empaneled under the scheme, they have the option to do so. The scheme allows for fee reimbursement to students who opt for non-empaneled coaching institutes, subject to the scheme's prescribed limits.

# Eligibility Criteria for Students under Jai Bhim Mukhyamantri Pratibha Vikas Yojna

To benefit from this scheme, eligible students must meet specific criteria, ensuring that the assistance reaches those who need it the most. The eligibility criteria are as follows:

- Residents of Delhi: Eligible students must be residents of Delhi, providing local support to those in need.
- Belonging to SC/ST/OBC/EWS Categories: This scheme is exclusively for students belonging to Scheduled Castes (SC), Scheduled Tribes (ST), Other Backward Classes (OBC), and Economically Weaker Sections (EWS).
- Annual Family Income Limit: The annual family income of eligible students must not exceed Rs. 8 lakhs, ensuring that the assistance reaches economically disadvantaged individuals.
- Education Criteria: Students must have completed their 10th and 12th classes from schools in Delhi, demonstrating a commitment to education and a local connection.
- **Eligibility for the Specific Exam:** Eligible students must meet the eligibility criteria set by the competitive examination they wish to prepare for.

# Required Documents to apply for Jai Bhim Mukhyamantri Pratibha Vikas Yojna

To apply for the scheme, eligible students need to submit the following documents:

- Caste Certificate: A valid caste certificate issued by the Competent Authority, confirming the student's category (SC/ST/OBC).
- Income Certificate: An income certificate, confirming that the annual family income is within the prescribed limit.
- EWS Certificate (if applicable): For students from the Economically Weaker Sections (EWS), an EWS certificate is required to validate their category.

# Application Process of Jai Bhim Mukhyamantri Pratibha Vikas Yojna

The application process for both empaneled and non-empaneled coaching institutes is outlined as follows:

- Empaneled Institutes: Students can apply directly to the empaneled institute for admission, using the prescribed format. Admission to empaneled institutes depends on meeting the eligibility criteria and seat availability. The institute is required to submit a list of admitted students to the Department within seven days from the start of the coaching program.
- Non-Empaneled Institutes: Students can apply directly for non-empaneled institutes, indicating their choice of coaching center. The application envelope should be marked with 'Application for coaching under Jai Bhim Mukhyamantri Pratibha Vikas Yojna.' Applications are submitted to the Deputy Director (Implementation) at the Department for the Welfare of SCs, STs, OBCs, GNCT of Delhi. Applications should be submitted within 30 days from the date of publication of the advertisement in newspapers. The Department scrutinizes applications and allows eligible students to avail coaching from non-empaneled institutes based on seat availability.
- Merit List for Over-Subscribed Categories: In cases where the number of applications under a particular category exceeds the available seats, a merit list is prepared based on the percentage of marks obtained in the 10th/12th
