









India's Defence Production Milestone in FY 2023-24

In the financial year 2023-24, India's Ministry of Defence announced a historic achievement in the country's indigenous defence production. Over the past five years, India's defence production has experienced a substantial increase. In FY 2019-20, the production value stood at Rs 79,071 crore. By FY 2023-24, this figure had grown by over 60%, highlighting the steady and significant progress in the sector. Record-Breaking Defence Exports


1. Surge in International Sales
