They link an independent clause to a relative clause, functioning like **adjectives**. Therefore, the clauses they create are also known as **adjective clauses**.

What are Clauses?

Clauses are groups of words that contain a subject and a predicate. They are the building blocks of sentences, allowing us to convey more complex ideas. There are two main types of clauses:

1. Independent Clauses:

- An independent clause, also known as a **main clause**, is a group of words that can stand alone as a complete sentence. It expresses a complete thought and includes a subject and a predicate.
- Example: "The sun was shining brightly."

2. Dependent Clauses:

- A dependent clause, also called a **subordinate or relative clause**, is a group of words that cannot stand alone as a complete sentence. It relies on an independent clause to form a complete thought.
- Example: "Although the sun was shining brightly, it was a cold day."

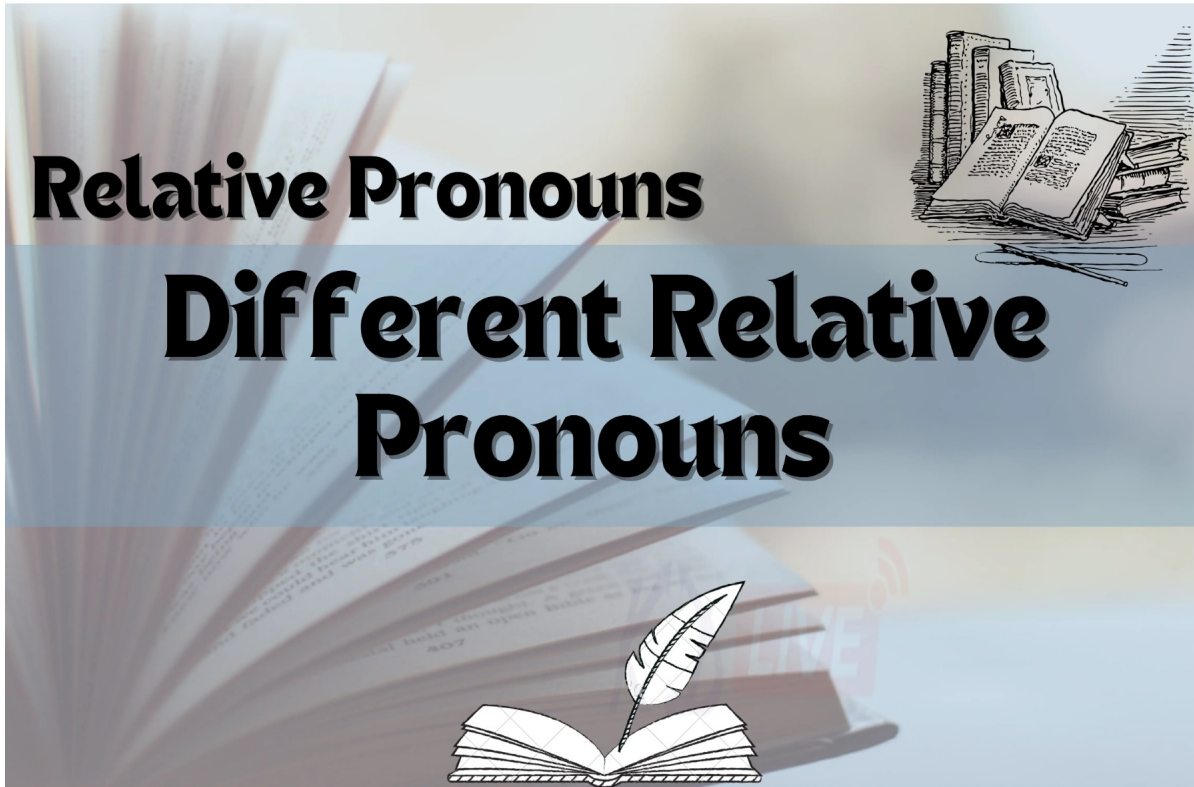
Knowing about clauses is necessary for understanding relative pronouns. Clauses allow us to express ideas and relationships between different parts of a sentence.

Functions of Relative Pronouns

1. **Adding Information:** Relative pronouns provide more information about the noun or the pronoun in the sentence, for example, "I found the pen that I lost yesterday."
2. **Defining or Non-defining:** "The girl who won the award is my sister." (Defining) vs. "My sister, who won the award, is very talented." (Non-defining)
3. **Possession:** Relative pronouns talk about ownership or to whom does the subject belong, for example, "She found a cat whose tail was fluffy."

Different Relative Pronouns

Relative pronouns help link information in a sentence, providing additional details and creating more complex and informative sentences.

- **Who/Whom:** Used for people.

Use: Introduces a relative clause providing more information about a person.

Examples: "The person **who/whom** I met yesterday is my new neighbor."

- **That/Which:** Used for things or animals.

Use: Introduces a relative clause providing more information about a thing or animal.

Example: "The book **that/which** is on the table belongs to me."

- **Whose:** Indicates possession.

Use: Introduces a relative clause indicating ownership or possession.

Example: "The girl **whose** bag was lost needs help finding it."

- **Where:** Relates to a place.

Use: Introduces a relative clause specifying the place associated with the main clause.

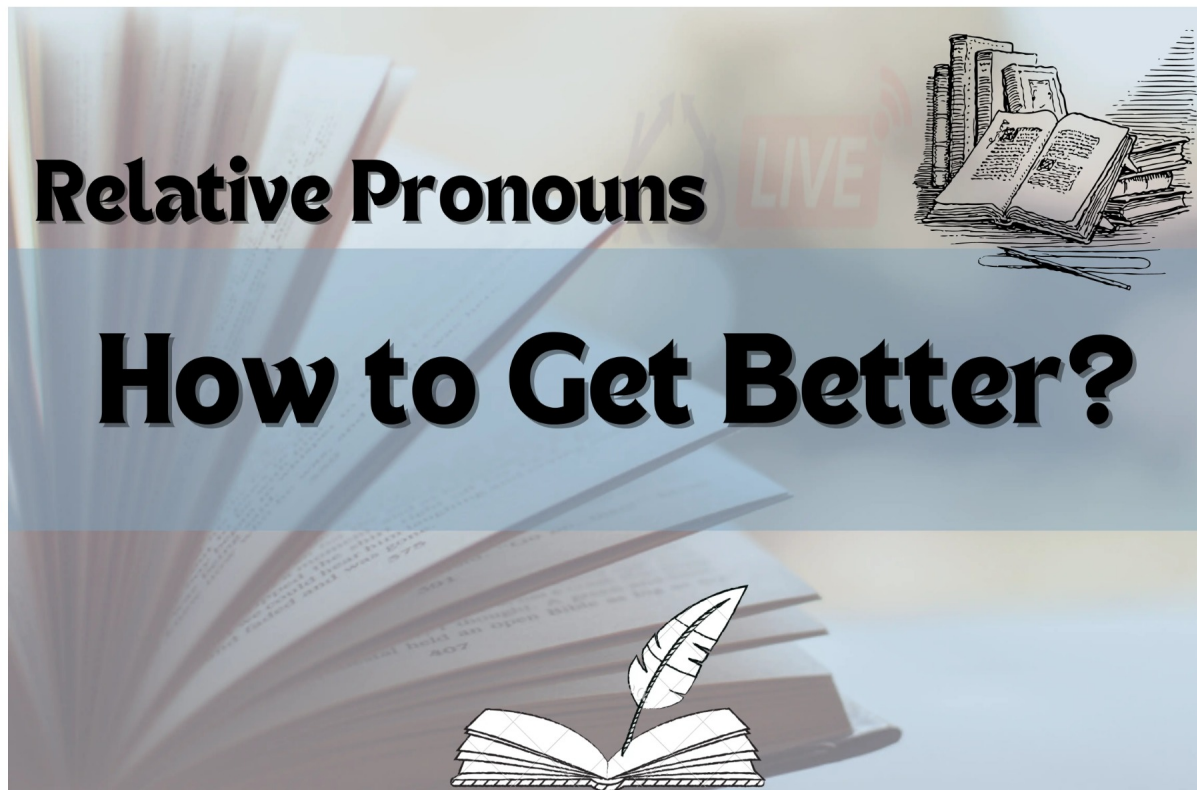
Example: "The house **where** I grew up holds many childhood memories."
