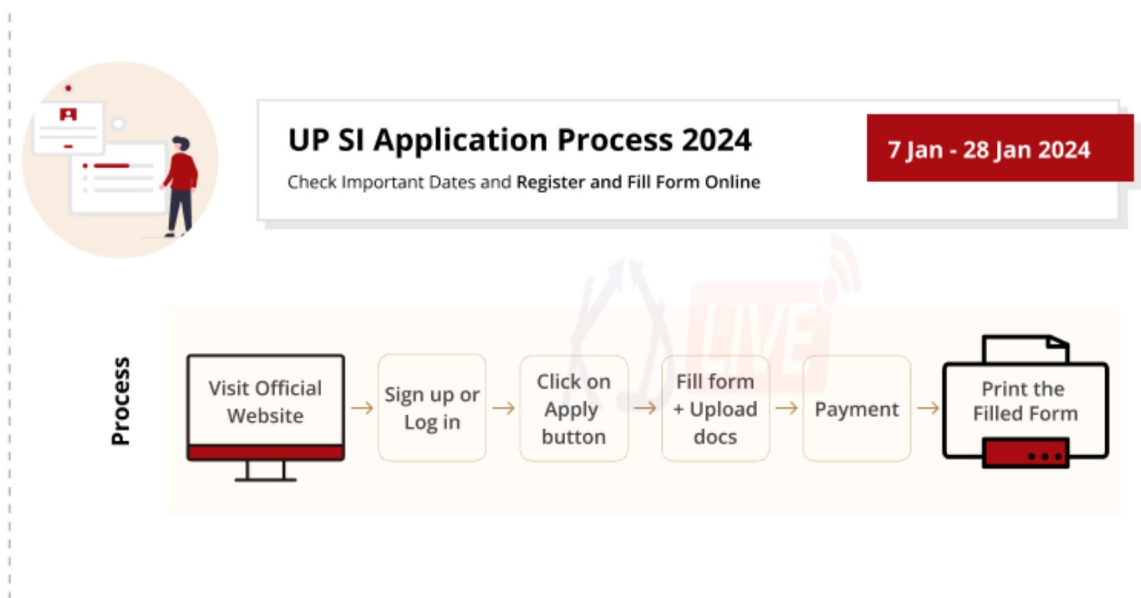

9. 'B' certificate of the National Cadet Corps (if it applies to you).
10. Territorial Army Service Certificate (if it applies to you).
11. NOC from Competent Authority (for a working UP State Government Civilian Employee).
12. Your 10th-grade mark sheet and 12th/HSC mark sheet or certificate.
13. Graduation Marksheet/Certificate.
14. A law degree from a university recognised by the University Grants Commission (UGC) (if it applies to you).

- You should be at least 21 years old by July 1, 2023, and your age should not exceed 28 years. This implies that your birth should fall between July 1, 1995, and July 1, 2002.
- If you belong to Other Backward Classes, Scheduled Castes, Scheduled Tribes, or other specified categories (specific to Uttar Pradesh residents), there's a provision for age relaxation in the maximum age limit as per the current government orders.

Educational Qualifications:

- You must possess a graduation degree from a recognised university.
- Additionally, you should be able to type a minimum of 25 words per minute in Hindi and 30 words per minute in English.
- Also, you must have completed a certified computer course at the "O" level.
