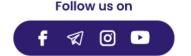

Eligibility of SSC CPO 2024 - Age, Nationality, and Education

Nationality

To be eligible for SSC CPO exam 2024, you must be either of the following:

- · a citizen of India, or
- a subject of Nepal, or a subject of Bhutan.
 - For those of you under above category must have a certificate of eligibility issued by the Government of India.

Age Limit

- Age limit is typically 20-25 years old (on August 1st, 2024). There are some exceptions for certain groups, like extra time for SC/ST or OBC candidates. We've got a table below showing the exact age relaxations.
- For Delhi Police Sub-Inspectors, unmarried women who are widowed, divorced, or separated can apply up to a higher age limit (35 or 40 years old depending on category).
- If you're already working for Delhi Police, you might have a different age limit depending on your category and how long you've been working.

There are some age relaxations that have been provided to certain categories of people. Moreover, to provide you with the same information, we have incorporated a snippet from the official notification itself.

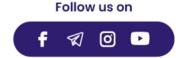

Eligibility of SSC CPO - Exam Pattern & Marking Scheme

Here's how the SSC CPO exam pattern looks like (based on the official notification):

- 1. **Tier 1:-** This is a computer-based test with 200 questions for a total of 2 hours. It covers four sections that are; General intelligence & reasoning, General knowledge & General awareness, Quantitative aptitude and English comprehension.
- 2. **Tier 2:-** If you qualify with the prelims exam and the PET/PMT, you'll take another online exam focused solely on English Language & Comprehension. This exam also has 200 marks and lasts 2 hours.

As we are aware, the CPO recruitment examination 2023 consists of two papers, both of which are objective multiple-choice questions. These questions will be presented in both Hindi and English. Moreover, they are presented within Parts I, II, and III of Paper 1. Additionally, there will be a provision for negative marking. **0.25 mark will be deducted for each incorrect answer** in both Papers 1 and 2. You can also check our blog on

Eligibility of SSC CPO - Syllabus

Now that you know the format of the SSC CPO exam (with Tier 1 and Tier 2), it's time to figure out what you actually need to study! The syllabus is like a road-map for your studying. It tells you what subjects to focus on, helps you pick the right study materials, and keeps you on track with your time. Here's a quick breakdown of Paper 1:

- General Intelligence & Reasoning: Think puzzles, problem-solving, and using your brain in different ways.
- General Knowledge & General Awareness: Stay informed about current events, history, science, and more!
- Quantitative Aptitude: Brush up on your math skills calculations, percentages, and other number problems.
- English Comprehension: Test your reading skills and understanding of the English language.

Paper 2 is just English Language and Comprehension, so you won't need to study other subjects for that one. To learn in detail about each of these subjects, you can read our blog,

Eligibility of SSC CPO - Posts & Salary

As the SSC CPO exam lets you compete for Sub-Inspector (SI) jobs in Delhi Police, Sub-Inspector (General Duty) roles in Central Armed Police Forces (CAPFs), and Assistant Sub-Inspector (ASI) positions in CISF.

And you know what the best part is? The job comes with a great salary and benefits package! Just remember, to become an SSC CPO officer, you'll need to be both physically fit and mentally sharp to handle the important duties.

Here's an overview of the SSC CPO salary, including some key highlights:

- Starting Salary: Successful candidates who qualify for the SSC CPO Exam can enjoy a starting salary of Rs. 35,400.
- Gross Salary: The gross salary, including various allowances, amounts to Rs. 47,496.
- Salary In-Hand: The in-hand salary, calculated after deductions, stands at Rs. 41,231, and can go as high as Rs. 1,12,000.


