

## **Age Limit**

To qualify for the exam, you must fall within the age range of 21 to 30 years as of October 31, 2023. Additionally, your date of birth should not be before 1st November 1993 or after October 31, 2002. However, certain categories are entitled to specific relaxations in the age criteria. You can go through the table below to know details of relaxations in the upper age limit.

#### Relaxation in Upper age limit:

SI.	Category	Age relaxation
1.	Scheduled Castes/ Scheduled Tribes	5 Years
2.	Other Backward Classes (Non-Creamy Layer)	3 Years
3.	Persons with Benchmark Disabilities - PwBD (SC/ ST)	15 Years
	(PwBD) - PwBD (OBC)	13 Years
	- PwBD (Gen/ EWS)	10 Years
4.	Eligible - Ex Servicemen, Commissioned officers including Emergency Commissioned Officers (ECOs)/ Short Service Commissioned Officers (SSCOs) who have rendered 5 years military service and have been released on completion of assignment (including those whose assignment is due to be completed within one year from the last date of receipt of application) otherwise than by way of dismissal or discharge on account of misconduct or inefficiency or physical disability attributable to military service or invalidment.

## **Essential Academic Qualifications**

According to the official notification, you must hold a graduation degree in any field from a recognized university or an equivalent qualification acknowledged by the Central Government, including Integrated Dual Degree (IDD). In case, you have qualifications in areas such as Medicine, Engineering, Chartered Accountancy, and Cost Accountancy, you are also deemed eligible.

You must note that the date of passing eligibility examination will be the date appearing on the mark sheet or provisional certificate issued by the University/ Institute. In case the result of a particular examination is posted on the website of the University/ Institute, a certificate issued by the appropriate authority of the University/ Institute indicating the date on which the result was posted on the website will be taken as the date of passing.

## **Experience (Post Essential Academic Qualification)**

As of October 31, 2023, it is requisite to possess at least 2 years of experience as an officer in a Scheduled Commercial Bank or any Regional Rural Bank listed in the Second Schedule of the Reserve Bank of India.

## **Local Language**

You should be proficient (reading, writing and understanding) in any one of the specified opted local language of the particular circle that you are applying for. Moreover, a test of knowledge of specified opted local language of the applied circle will be conducted as a part of the selection process. This test will be conducted for all the provisionally selected candidates (based on performance in online test, screening and interview). If you fail to qualify this test, you will not be offered appointment.



Now, let's proceed to grasp the exam pattern of SBI CBO 2023. The SBI CBO consists of an Online Test followed by a Screening and an Interview. The Online Test further comprises of two tests - an Objective Test for 120 marks and a Descriptive Test for 50 marks.

(i) **Objective Test**: The duration of objective test is 2 hours and it consists of 4 Sections of total 120 marks. There will be separate timing for every section.


(ii) **Descriptive Test**: The duration of Descriptive Test is 30 minutes. It will be a Test of English Language (Letter Writing & Essay) with two questions for total 50 marks.

Presently, the starting basic pay is 36,000/- in the scale of 36000-1490/7-46430-1740/2-49910-1990/7-63840 applicable to Junior Management Grade Scale-I plus 2 advance increments (For work experience of 2 years or more in officer cadre in any Scheduled Commercial Bank/Regional Rural Bank). As a Circle Based Official, you will also be eligible for D.A, H.R.A/ Lease rental, C.C.A, Medical and other allowances & perquisites as per rules in force from time to time.
