#### Nationality

To be eligible for the SSC CPO Exam 2023, you must fall under one of the following categories:

- A citizen of India, or
- A subject of Nepal, or
- A subject of Bhutan

SSC CPO Eligibility Criteria 2023 - Age, Education

One very important point to take in consideration is that the latter two must fulfill all the SSC CPO Eligibility Citeria 2023 requirements under the eligibility certificate issued by the government of India. If you are someone whose certification of eligibility is mandatory, you can give the exam without the certification. However, the offer of appointment will be given to you only when the certificate of eligibility is issued to you by the Government of India.

#### Age Limit

The age criteria for the SSC CPO Exam 2023 are as follows:

• For Sub-Inspector (GD) in CAPFs and Delhi Police and Assistant Sub-Inspector (Executive) in CISF: You must be between 20 to 25 years old as on 1st August 2023.

Note that the age relaxation for reserved categories will be applicable as per the government norms. Thus, for your reference, we have attached the table containing the years of relaxation for various categories.

Permissible relaxation in upper age limit for different categories in accordance with extant rules/ guidelines of Government of India are as under:

- · You must have been graduated from a recognized university or equivalent.
- If you are someone who has appeared in his/ her Bachelor's degree or equivalent examination can also apply; however, you must possess the essential qualification on or before the cutoff date i.e., 15.08.2023.

SSC CPO Eligibility Criteria 2023 - Age, Education

Meeting the SSC CPO Eligibility Criteria 2023 is the fundamental requirement to apply for the SSC CPO Exam 2023. Thus, it is extremely crucial for you to meet the requirements of the Physical Qualification. Remember that this is an SSC CPO Eligibility Criteria 2023 but it also falls under the Physical Standard Test. However, it is mandatory to meet these physical standards, and so you must keep these set standards in your minds. Let's see what these set standards are for both men and women in the table given below:



- SSC CPO Notification 2023 PDF was released on 22nd July 2023 on the official SSC website.
- As per the notification, SSC CPO exam aims to fill 1876 vacancies for the post of SI in CAPF and Delhi Police.
- Above given vacancies are inclusive of BSF, CISF, CRPF, ITBP, SSB, and the Delhi Police.
- Moreover, this is an annually recurring recruitment examination conducted by the Staff Selection Commission.



• Firstly, Paper 1 is conducted for the SSC CPO examination.



Now equipped with a comprehensive understanding of crucial exam components, the natural inclination is to seek information about the salary structure. Without further delay, let us delve into that aspect.

### SSC CPO SI Post and Salary

It is not a hidden fact that future security and salary are the main attraction points for all government exams. And SSC CPO is a complete package when it comes to that. Along with a well-paid salary, allowances, and an assured future through a pension, it also provides a few of the most respected posts.

The pay scale after clearing SSC CPO 2023 exam, however, varies as per the post, the candidate qualifies for.

#### The variation can be sub-categorized as below:

- Sub-Inspector (GD) in CAPFs: The post carries a pay scale of Level-6 (Rs.35,400 Rs.1,12,400/-) and is classified as Group 'B' (Non-Gazetted), Non-Ministerial.
- Sub-Inspector (Executive) (Male/Female) in Delhi Police: The post carries a pay scale of Level-6 (Rs.35,400 Rs.1,12,400/-) and is classified as Group 'C' by Delhi Police.

Fulfilling the SSC CPO Eligibility Criteria 2023 is the first step towards a successful application for the SSC CPO 2023 exam. Make sure you meet the nationality, age, educational qualification, and physical standards requirements specified in the official notification.
