

Nationality

The first criteria under the SSC Stenographer Eligibility Criteria 2023 is the Nationality. To be eligible for the SSC Stenographer examination in 2023, you must fall into one of the following categories when it comes to the SSC Stenographer Eligibility Criteria 2023 for the nationality:

Citizenship by Birth:

- If you were born in India on or after January 26, 1950, but before July 1, 1987.
- If you were born in India on or after July 1, 1987, to at least one Indian citizen parent.

Citizenship by Descent:

• If you were born outside India on or after January 26, 1950, but before December 10, 1992, to parents who are Indian citizens by birth.

Citizenship by Registration:

- If you are a citizen of India, or a subject of Bhutan, or Nepal,
- If you are a Tibetan refugee who came to India before 1962 with the aim of permanently settling in India.
- If you have permanently migrated from Pakistan, Myanmar, Sri Lanka, Kenya, Uganda, Tanzania, Zambia, Malawi, Zaire, Ethiopia, or Vietnam to settle in India.

Educational Qualification

The second criteria under the SSC Stenographer Eligibility Criteria 2023 is the Eductional Qualification.

- You must have completed your 12th standard (intermediate) or equivalent examination from a recognized board or university as of the specified date.
- Remember that you must possess an essential educational qualification on or before the closing date for receipt of online applications.

Age Limit

Lastly, the third criteria under the SSC Stenographer Eligibility Criteria 2023 is the Age. The age limit varies for both Stenographer Grade 'C' and Stenographer Grade 'D'. Let us understand these in details in the bullet points given below:

- Stenographer Grade 'C': 18 to 30 years as on 01.08.2023, 6 i.e., you should not be born before 02.08.1993 and after 01.08.2005 to be eligible to apply.
- Stenographer Grade 'D': 18 to 27 years as on 01.08.2023, i.e., you should not be born before 02.08.1996 and after 01.08.2005 to be eligible to apply.

The Staff Selection Commission of India has provided age relaxation to various categories. Therefore, the image below explains the SSC stenographer age relaxation for the year 2023. So, scan through it to clear all your doubts and gain more clarity.



The details of the Shorthand Skill Test for SSC Stenographer 2023 are mentioned below:

Those of you who qualify for the computer based test will be eligible for the shorthand skill test. Let's understand much better with the help of the points below:

- The skill test is of a qualifying nature, and the Commission will establish qualifying standards for different candidate categories.
- The skill test involves stenography, where candidates will be given one **10-minute dictation in English or Hindi** at speeds of **100 words per minute** for stenographer grade 'C' and **80 words per minute** for stenographer grade 'D.'
- Transcription of the dictation must be done on a computer.


