











UP SI Age Limit 2024 - Know Detailed Eligibility Criteria

To be eligible for the UP SI recruitment in 2024, applicants must meet specific age criteria. Candidates must be a minimum of 21 years old as of July 1, 2023, and should not exceed 28 years of age, meaning they must have been born before July 1, 1995, or after July 1, 2002.

It's important to note that candidates belonging to Other Backward Classes (OBC), Scheduled Castes (SC), Scheduled Tribes (ST), and similar categories are eligible for age relaxation as per government regulations. Additionally, only individuals who are natives of Uttar Pradesh are eligible to apply for the UP SI recruitment.

UP SI Nationality 2024

- Certificate of Eligibility: Candidates falling under categories (2), (3), (4), and (5) mentioned above need to obtain the required certificate of eligibility issued by the Government of India for the application process.

UP SI Educational Qualifications 2024

To meet the eligibility criteria for the UP Police SI post, you must have a bachelor's degree from any stream obtained from an accredited university or institution. This means you need to have completed your undergraduate studies and obtained a degree recognized by the University Grants Commission (UGC), which ensures the standardization and quality of university education in India. Holding a bachelor's degree demonstrates that you have the necessary foundational knowledge and skills required for the responsibilities associated with the position of a Sub-Inspector in the Uttar Pradesh Police force.

In addition to the aforementioned primary UP SI eligibility criteria 2024, there are a few additional requirements as outlined below:

Marital Status: A male candidate with more than one living wife or a female candidate married to a man with an existing living wife will not be eligible for appointment.


