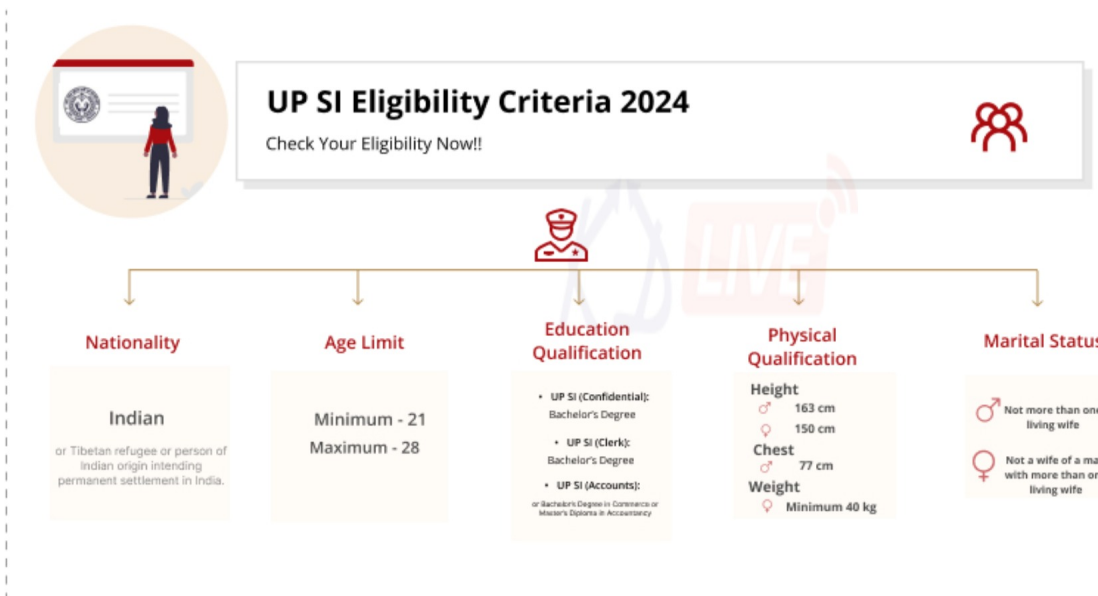


UP SI Eligibility Criteria 2024 - Age, Education

On December 28, 2023, the Uttar Pradesh Police Recruitment and Promotion Board (UPPRPB) just published the UP SI Notification 2024. Based on the official announcements, this comprehensive guide provides all the relevant information about the UP SI Eligibility Criteria 2024.

UP SI 2024 Eligibility Criteria

Before you start applying, make sure you understand the UP SI Eligibility Criteria 2024. These criteria primarily include nationality, a minimum educational qualification and an age limit. Let us briefly explain these UP SI Eligibility Criteria 2024.

Nationality

The following conditions are essential for determining nationality.

- You must be a citizen of India, or
- A Tibetan refugee who arrived in India prior to January 1, 1962, with the intention of permanently settling in India, or
- Individuals of Indian origin migrating from Pakistan, Guyana, Sri Lanka, or East African countries such as Kenya, Uganda, and the United Republic of Tanzania (formerly Tanganyika and Zanzibar) are eligible, provided they have the intention of permanently settling in India.

Most importantly, candidates falling into the last two categories must possess a certificate of eligibility issued by the State Government.

UP SI Eligibility Criteria 2024 - Age, Education

Educational Qualification

Each stream has a particular educational prerequisite as the third UP SI eligibility criteria 2024 , which is covered in more detail below:

For the post of Sub Inspector of Police (Confidential):

- Graduation degree from a University established by law in India or equivalent qualification recognized by the Government.
- Proficiency in Hindi typing (in Unicode on Inscript keyboard) at a minimum speed of 25 words per minute and English typing at a minimum speed of 30 words per minute.
- Ability to take Hindi shorthand dictation at a minimum speed of 80 words per minute. (Candidates will be declared successful based on standards set by the Uttar Pradesh Police Recruitment and Promotion Board.)
- Successful completion of the "O' Level examination in Computer" from the National Institute of Electronics and Audio Technology (NIELIT Society) (formerly Doyak Society) of the Government of India or any qualification recognized as equivalent by the Government is a prerequisite.

For the post of Assistant Sub Inspector of Police (Clerk):

- Possession of a graduation degree from a University established by law in India or an equivalent qualification recognized by the Government.
- Proficiency in Hindi typing (in Unicode on Inscript keyboard) at a minimum speed of 25 words per minute and English typing at a minimum speed of 30 words per minute.
- Successful completion of the "O" Level examination in Computer from the National Institute of Electronics and Audio Technology (NIELIT Society) (formerly Doyak Society) of the Government of India or any qualification recognized as equivalent by the Government is mandatory.

For the post of Assistant Sub Inspector of Police (Accounts):

- Possession of a Bachelor's degree in Commerce or Master's Diploma in Accountancy from a University established by law in India or an equivalent qualification recognized by the Government.
- Proficiency in Hindi typing (in Unicode on Inscript keyboard) at a minimum speed of 15 words per minute.
- Successful completion of the "O" Level examination in Computer from the National Institute of Electronics and Audio Technology (NIELIT Society) (formerly Doyak Society) of the Government of India or any qualification recognized as equivalent by the Government is a prerequisite.

Age Limit (1/07/2023)

The candidate should be at least 21 years old as of July 1, 2023, and should not exceed 28 years of age, meaning the candidate's birth should fall between July 1, 1995, and July 1, 2002.

However, there is a provision for age relaxation in the maximum age limit for candidates belonging to Other Backward Classes, Scheduled Castes, Scheduled Tribes, and other specified categories (limited to natives of Uttar Pradesh) as per the prevailing Government Orders.

In addition to the aforementioned primary UP SI eligibility criteria 2024, there are a few additional requirements as outlined below:

Marital Status: A male candidate with more than one living wife or a female candidate married to a man with an existing living wife will not be eligible for appointment.

Physical Standard Test (PST):
