## SSC MTS Exam Pattern - An Overview

In the SSC MTS Exam Pattern, the examination is conducted in two sessions: Session-I and Session-II, both of which are mandatory for all candidates. In Session-I, multiple-choice questions with objective answers are provided. Notably, there is no negative marking in this session. However, in Session-II, each incorrect response leads to a deduction of one mark. Additionally, marks are adjusted through a normalization process. It's important to note that questions are available in English, Hindi, and 13 other languages.

## SSC MTS Exam Pattern - 90 Questions in 90 Minutes

To get started, let's delve into the SSC MTS Exam Pattern, tailored just for you. It encompasses two key stages: a Computer Based Exam (CBE) and a Physical Efficiency Test and Physical Standard Test, applicable only if you're aiming for a Havaldar position in CBIN or CBN. We'll focus solely on the CBE for now.

Here's how the Computer Based Examination (CBE) is structured for you:

- In Session 1, you'll tackle 40 questions, each worth 3 marks.
- Session 2 presents 50 questions, also valued at 3 marks each.
- Each session grants you 45 minutes for completion.
- Notably, there's no penalty for incorrect answers in Session 1.
- However, in Session 2, each wrong answer incurs a deduction of 1 mark. But remember, no marks are deducted for unanswered questions.
- If you're eligible for a scribe, you'll receive an extended 60 minutes per session for solving questions, instead of the standard 45 minutes.

Additionally, for your reference, here's a snippet from the official SSC MTS Notification 2024:

Secondly, when considering the SSC MTS Exam Pattern, you'll find that the Physical Standard Test (PST) or the Physical Endurance Test (PET) holds a significant importance. Once you've successfully completed and qualified the CBE, it's imperative to undergo the PST or PET. Remember, clearing PST/PET is mandatory if your goal is to become a Havaldar in either the Central Board of Indirect Taxes and Customs (CBIN) or the Central Bureau of Narcotics (CBN). Let's now explore the specifics of each of these:

## Physical Standards for Test

Physical Standards Test (PST) acts as a crucial eligibility benchmark, establishing standard requirements for:

- Height
- Chest
- Weight

These criteria vary for both men and women. Below, we've included a table outlining the precise measurements for height, chest, and weight necessary for the PST.

Details	Male	Female
Height(in cm)	157.5	152
Unexpanded Chest (in cm)	81	-
Expanded Chest (in cm)	86	-
Weight (in kg)	-	48

Now that you have a clear understanding of the physical standards you need to meet, let's proceed to explore the components of the Physical Efficiency Test (PET).

## Physical Efficiency Test

The purpose of the Physical Efficiency Test (PET) is evident. It evaluates your fitness level after successfully passing the Computer Based Examination and qualifying for the PST. Let's delve deeper into the specifics:

Firstly, if you're a Male Candidate, your PET entails the following:

- Completing a 1600-meter run within 15 minutes

Secondly, if you're a Female Candidate, your PET comprises:

- Completing a 1-kilometer run within 20 minutes

Moreover, if you find yourself 12 weeks pregnant during the PET, you'll be temporarily deemed unfit for examination. However, your position will be reserved, and you'll have the opportunity for re-examination six weeks after delivery, or earlier if you provide a medical certificate of fitness from a registered medical professional.

Candidates with specified disabilities may qualify for exemption from the Physical Efficiency Test. Additionally, please take note of the following:

S. No.	Suitable category for benchmark disability for post of Havaladar	Exemption in PET/PST
1.	HH	No exemption
2.	OA	No exemption
3.	OL	May be exempted from Walking
4.	OAL	May be exempted from Walking
5.	LC	May be exempted from Walking
6.	AAV	No exemption However. If due to acid attack the candidates suffer from orthopaedic disability i.e. OA, OL, OAL, then above exemption for OA , OL and OAL will apply
7.	MD involving above categories	Above exemption for HH ,OA , OL , OAL , LC , and AAV will apply

Abbreviations used: HH = Hard of Hearing, OA= One Arm, OL= One Leg, OAL= One Arm & One Leg, LC= Leprosy Cured, AAV = Acid Attack Victim, MD = Multiple Disabilities.

## SSC MTS Exam Pattern - Important Points

There are some points to remember if you are appearing for the SSC MTS Examination and those points are as follows:

1. The total score you can achieve in the exam is 270 marks.
2. The initial paper presents questions with multiple-choice options to choose from.
3. Questions are available in English, Hindi, and 13 other regional languages for the first session and for the General Awareness segment of the second session.
4. In the second session, if you answer a question incorrectly, you'll lose 1 mark due to negative marking. However, no negative marking applies in the first session.
5. Candidates with visual impairment and cerebral palsy are allotted 45 minutes for each session.

## SSC MTS Syllabus

### Session I

#### Key facts about Session I:

- 20 questions per subject
- Each question carries 3 marks
- No negative marking

### Session II

Following the SSC MTS Exam Pattern, Session 2 is also mandatory. The subjects in this session are:

- General Awareness
- English Language and Comprehension

#### Key facts about Session 2:

- 25 questions per subject
- Each question is worth 3 marks
- Negative marking of one mark for each wrong answer; no negative marking for unattempted questions

## SSC MTS Marking Scheme

In the SSC MTS Exam, candidates will encounter a two-session format. Each session will consist of objective multiple-choice questions. Notably, questions in both sessions will be available in Hindi, English, and 13 regional languages, catering to diverse linguistic preferences. It's worth noting that while there's no negative marking in session 1 papers, session 2 papers carry a penalty of one mark for each incorrect answer.
