

- Like Tier I, Tier II is online and assesses your suitability for different positions in the SSC CGL 2024 exam.

# SSC CGL 2024 Selection Process - Part I

In the SSC CGL 2024 selection process, you will take the Tier 1 Exam online. It includes four sections with a total of 100 Multiple-Choice Questions (MCQs). You have a maximum of 200 marks for this tier, and you are given 60 minutes to complete the entire exam.

## · SSC CGL Tier-1 Exam Structure (2024):

- Conducted online with four sections.
- Total of 100 multiple-choice questions (MCQs).
- o Maximum marks: 200.
- o Time limit: 60 minutes.
- Negative marking: 0.5 mark

#### Qualifying Nature:

• Marks obtained in Tier-1 are not considered for the final selection.

#### Sections in SSC CGL Tier-1 Exam 2024:

- 1. General Intelligence & Reasoning
- 2. General Awareness
- 3. Quantitative Aptitude
- 4. English Comprehension

This tier will assess you across above mentioned subjects, providing a foundation for the subsequent stages in the SSC CGL 2024 selection process.

# SSC CGL 2024 Selection Process - Part II

In the SSC CGL 2024 selection process Tier 2, the examination is divided into three phases - Paper I, Paper II, and Paper III. Paper I is compulsory for all posts, Paper II is for those of you applying for the Junior Statistical Officer (JSO) positions, and Paper III is for those aspiring to be Assistant Audit Officer/Assistant Accounts Officer.

## Paper I (Compulsory) Structure:

- Divided into two sessions: Session I and Session II.
- Session I contains three sections.
  - Section I includes Mathematical Abilities and Reasoning and General Intelligence.
  - Section II comprises English Language and Comprehension and General Awareness.
  - Section III of Session I of Paper I includes a Computer Knowledge Test (Qualifying, 15 minutes).
- ° Session II of Paper I includes a Data Entry Speed Test Module.

#### · Paper II & III Structure:

- Paper II: Statistics (100 questions, 200 marks, 2 hours).
- Paper III: General Studies (Finance and Economics) (100 questions, 200 marks, 2 hours).

## Negative Marking:

- Deduction of 1 mark for each wrong answer in Section-I, Section-II, and Module-I of Section-III in Paper I.
- Deduction of 0.50 marks for each incorrect response in Paper II and Paper III.

To provide you with more clarity, we have incorporated a snippet from SSC CGL 2023 official notification, since 2024 official notification is yet to be released.

This stage holds immense importance, demanding your presence before the designated Document Verification Committee on the specified date. Missing this crucial appointment may pose a risk to your selection prospects. To smoothly navigate through this verification process, ensure you bring the following original documents/certificates, backed by two self-attested copies, when facing the Document Verification Committee:

- Copy of Online Application Form
- Two passport size recent color photographs
- Original photo ID Proof (Aadhar card/Voter Card/Pan Card/Passport, etc.)
- D.O.B Certificate (10th Diploma/Marks card)
- Valid Category Certificate, if applicable
- · Domicile Certificate
- 10+2 Marks Sheet
- Graduation Degree from a recognized University/Institute
- Bonafide certificate on the format prescribed by the SSC CGL 2024 Board, duly issued by the Controller/Registrar of the concerned University for candidates who have obtained Degrees from the Universities/Colleges
- Other documents as per prescribed qualifications mentioned in the Advertisement Notification. Ensure that you adhere to these requirements diligently to facilitate a smooth and successful completion of the SSC CGL 2024 selection journey.

# SSC CGL 2024 Eligibility Criteria

SSC provides a diverse array of opportunities for government job aspirants in esteemed departments. Aspiring candidates can find detailed information about the various posts offered, each falling under distinct departments with specified age limits. The SSC CGL 2024 Notification comprehensively outlines these age criteria, and the following table offers a concise overview:

# **Nationality**

- · You must be either a citizen of India or,
- · A subject of Nepal or Bhutan.
- An individual of Indian origin who has relocated from Pakistan, Burma, Sri Lanka, and East African Countries such as Kenya, Uganda, the United Republic of Tanzania (formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire, Ethiopia, and Vietnam, with the intention of establishing permanent residence in India.

• You must fall within the age range of 18 to 32 years. Moreover, it's important to note that various positions might have distinct age criteria.

# **Educational Qualification**

- For the post of Assistant Audit Officer/Assistant Accounts Officer- Bachelor's Degree from a recognized University or Institute.
- For the post of Junior Statistical Officer- A candidate must hold a Bachelor's Degree in any subject from a recognized University or Institute with a minimum of 60% marks in Mathematics at the 12th standard level. Alternatively, a Bachelor's Degree in any subject with Statistics as one of the subjects at the degree level is also acceptable.
- For the post of Statistical Investigator Grade II- A candidate should possess a Bachelor's Degree in any subject with Statistics as one of the subjects from a recognized University or Institute.
- For all the other posts- Bachelor's Degree from a recognized University or equivalent.

If you fall under the last two categories, you are required to possess a certificate of eligibility issued by the Government of India.

# SSC CGL 2024 Important Dates

Save the date, June 11, 2024, for the big reveal of the SSC CGL 2024 notification by the Staff Selection Commission. To assist your preparation, the SSC also shared an exam calendar (2024-25) on November 2, 2024. It recommends all CGL aspirants begin their preparations promptly. Take note that the application window is open until July 10, 2024, after which the forms won't be available. Additionally, mark your calendars for the SSC CGL exam scheduled for the months of September-October 2024.


