



MLA Full Form - Qualification Standards for an MLA

To be elected as an MLA, certain qualifications must be met:

- Indian citizenship
- · Minimum age requirements (25 years for legislative assembly)
- · Voter eligibility in any Legislative Assembly constituency in the state
- Not holding any office of profit under the Government of India or any state, except that of a Union Minister
- · Not having been convicted by a court or found guilty in a specific incident
- · Not being confirmed convicted of any offense with a imprisonment term of two years or more



MLAs balance their time between their electorate and their legislative duties. Duties vary based on whether they are part of the Cabinet, Opposition, or Government Backbench.

- **Opposition Members:** Focus on researching and asking questions in the House regarding their constituency and critical areas.
- Cabinet Members: Oversee operations of assigned departments, answer Opposition queries, present Government Bills, and manage Estimates and Annual Reports.

MLA Full Form - Powers Provided to an MLA

Powers are divided between the parliament and the state legislature, including:

- Parliamentary Powers: Lawmaking, coordinating police, prison decisions, irrigation, agriculture, local government, public health, pilgrimage welfare, and burial grounds.
- State and Parliamentary Powers: Education, marriage, divorce, forests management, and wildlife protection.


