










#### International Day of the World's Indigenous Peoples

### International Day of the World's Indigenous Peoples

- 1. **United Nations Declaration on the Rights of Indigenous People (UNDRIP)**: Adopted by the UN General Assembly in 2007, UNDRIP is a comprehensive statement of the rights of indigenous people, including their rights to self-determination, lands, territories, and resources, as well as their cultural, social, and economic rights.
- International Labour Organization (ILO) Convention 169: Adopted in 1989, this convention concerns indigenous
  and tribal people in independent countries and aims to protect their rights and ensure their participation in
  decisions affecting their lives.
- 3. **World Conference on Indigenous People (WCIP)**: Held in 2014, the WCIP was a significant event that brought together indigenous representatives, member states, and observers to discuss the challenges and opportunities facing indigenous people and to reaffirm the commitment to implementing the UNDRIP.


