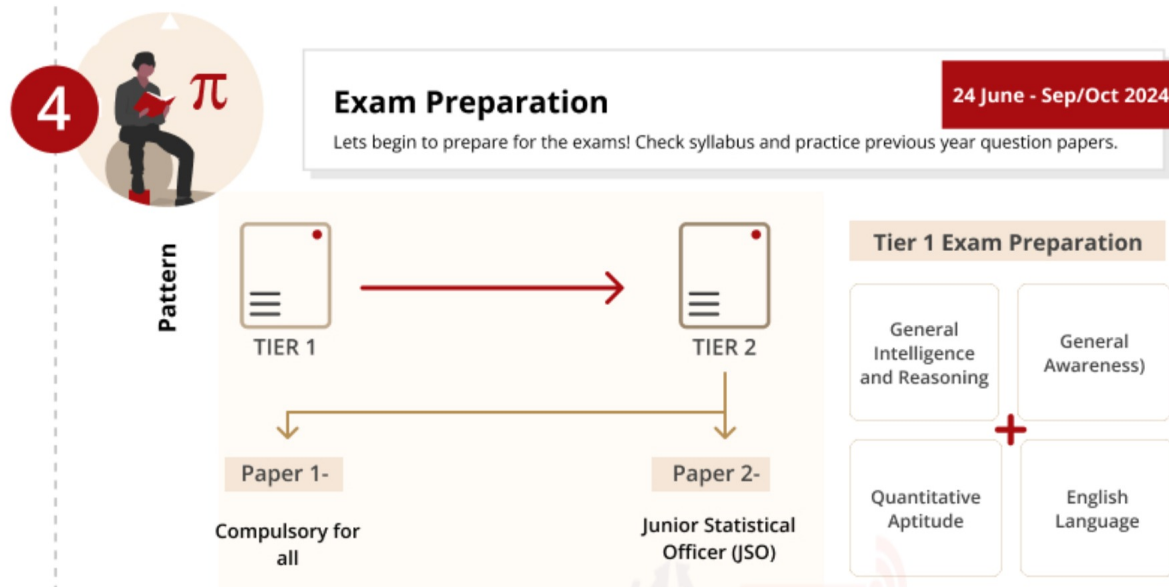

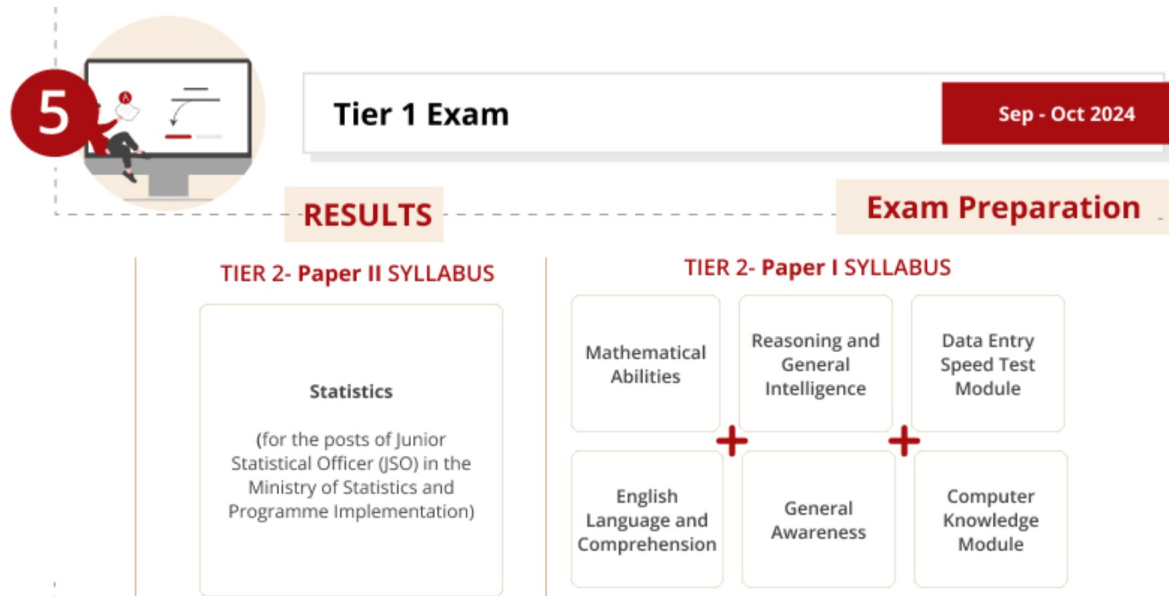

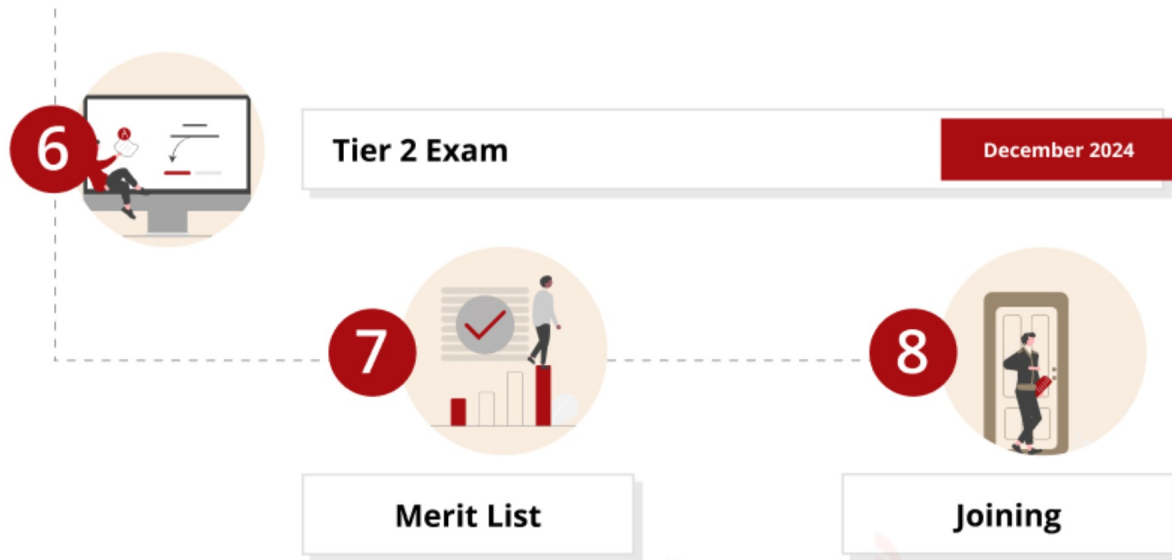

## SSC CGL Recruitment 2024 - Eligibility Criteria

Before diving headfirst into the application of SSC CGL Recruitment 2024, it's crucial to check if you meet the eligibility criteria. In this segment, we help you determine your SSC CGL eligibility criteria for 2024!

### Nationality

You must be a citizen of India, a subject of Nepal or Bhutan, or a person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka, East African countries of Kenya, Uganda, the United Republic of Tanzania (formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire, Ethiopia, and Vietnam with the intention of permanently settling in India.

### Age (as on 01-08-2024)

The age requirement ranges from 18 to 32 years old, though it's essential to note that this limit varies depending on the specific post. For detailed information on the age limits according to the post you are interested in, please refer to the official notification from page 2 onwards.

## Educational Qualifications

The required degree depends on the specific post you're applying for:

- **Research Assistant in National Human Rights Commission (NHRC):** Bachelor's Degree from a recognized university or institute.
- **Junior Statistical Officer:** Bachelor's Degree in any subject with a minimum of 60% marks in Mathematics at the 12th standard level, or a Bachelor's Degree with Statistics as one of the subjects.
- **Statistical Investigator Grade II:** Bachelor's Degree with Statistics as one of the subjects.
- **All Other Posts:** Bachelor's Degree from a recognized university or equivalent.

## Tier 1

- SSC CGL Tier 1 comprises four subjects.
- Moreover, Tier 1 consists of 100 Objective Type, Multiple Choice Questions with a maximum score of 200.
- The questions will be available in both English and Hindi, except for English Comprehension.
- Additionally, there is a negative marking of 0.50 for each incorrect answer.

## Tier 2

- Tier 2 of SSC CGL includes two papers: Paper I and Paper II.
- Paper I is compulsory for all applicants.
- Paper II is specifically for candidates applying for Junior Statistical Officer (JSO) in the Ministry of Statistics and Programme Implementation and Statistical Investigator Grade-II in the office of Registrar General of India (M/o Home Affairs), who qualify in Tier-I for these posts.
- Both Paper I and Paper II in Tier 2 consist of Objective Type, Multiple Choice Questions, except for Module II of Section III in Paper I.
- Questions will be provided in both English and Hindi, except for the English Language and Comprehension module in Section II of Paper I.
- There is a negative marking of 1 mark for each wrong answer in Section I, Section II, and Module I of Section III of Paper I, and 0.50 marks for each wrong answer in Paper II.

To begin the online application process, you need to complete two parts: First, perform One-Time Registration. Second, fill out the online application for the examination.

- Begin by clicking on the 'Register Now' link in the 'Login or Register' Section on the Commission's new website at <https://ssc.gov.in> for One-Time Registration.
- Complete the One-Time Registration by providing:
  - Personal Details
  - Create a Password
  - Additional Details
  - Declaration
- To fill out the online application, log in using your 'Registration Number' and password.
- Navigate to the 'Latest Notifications' tab and click on 'Apply' under the 'Combined Graduate Level Examination, 2024' Section.
- Enter all required information and upload your live Photograph and signature.
- Proceed to make the fee payment unless exempted.
- Once submitted, the application will be accepted 'Provisionally'.
- Print a copy of the application form for your records and to submit to the Commission after the Computer-Based Examination, as required.

## SSC CGL Recruitment 2024 - Application Fees

To proceed with your application, you'll need to pay a fee of ₹100/- (Rs one hundred only). However, please note that women candidates and those belonging to Scheduled Castes (SC), Scheduled Tribes (ST), Persons with Benchmark Disabilities (PwBD), and Ex-servicemen (ESM) eligible for reservation are exempt from this fee. You can conveniently pay the fee online through BHIM UPI, Net Banking, or using Visa, Mastercard, Maestro, or RuPay Debit cards. Remember, the online fee payment option will be available to you until 25 July 2024 (23:00 hours). Please be aware that once paid, the fee cannot be refunded under any circumstances, nor can it be adjusted against any other examination or selection process.
