Before diving headfirst into the SSC CGL Recruitment 2024 application, it's crucial to check if you meet the eligibility criteria. This blog clarifies everything you need to know to get started!

Who Can Apply?

- Nationality: You must be a citizen of India, a subject of Nepal or Bhutan, or a person of Indian origin who has migrated from specific countries with the intention of permanently settling in India (details provided in the blog).
- Age: You need to be between 18 and 32 years old. Remember, some positions may have slightly different age requirements.

Educational Qualifications:

The required degree depends on the specific post you're applying for:

- Assistant Audit Officer/Assistant Accounts Officer: Bachelor's Degree from a recognized university or institute.
- Junior Statistical Officer: Bachelor's Degree in any subject with a minimum of 60% marks in Mathematics at the 12th standard level, or a Bachelor's Degree with Statistics as a subject.
- Statistical Investigator Grade II: Bachelor's Degree with Statistics as one of the subjects.
- All Other Posts: Bachelor's Degree from a recognized university or equivalent.



- SSC CGL Tier 2 Exam 2024 will be conducted in 3 phases- Paper I, Paper II, and Paper III.
- You must successfully pass all sections of Paper I, as it is a mandatory requirement.
- Negative marking will apply, deducting 1 mark for each incorrect response in Section I, Section II, and Module I of Section III in Paper I, and 0.50 marks for each wrong answer in Paper II and Paper III.
- Lastly, questions will be provided in both English and Hindi languages, except for the English Comprehension section.



- In **Tier I** of the exam, there are in total of 100 questions that mark up to 200 marks. Thus, providing 2 marks for each question.
- Further, there will be a penalty of 0.50 marks for each incorrect answer in Tier I.
- In **Tier II** of the exam, there will be a deduction of **1 mark** for each incorrect answer in Section-I, Section-II, and Module-I of Section-III of Paper-I.
- Moreover, for Paper II and Paper III, there will be a penalty of 0.50 marks for every wrong answer.

SSC CGL Tier 1 Exam Pattern

The SSC CGL Tier-1 exam is a common and compulsory exam for each of the posts. The Tier-1 exam is qualifying in nature and will be conducted for a total of 200 marks. Candidates will be required to answer 25 questions from each of the 4 sections of the exam pattern over a duration of 1 hour. Each question will carry 2 marks. There will also be a negative marking penalty of 0.5 mark for each wrong answer.

The Tier 1 of the examination comprises of 4 subjects:

- General Intelligence and Reasoning
- General Awareness
- · Quantitative Aptitude
- English Comprehension


The Tier 2 examination comprises of 3 Papers:

- Paper II: Statistics
