

SSC CPO 2024 - Documents for Application

When applying for SSC CPO 2024, it is important to submit the necessary documents as indicated in the application form. These essential documents include:

- Scanned colour passport-size photograph in JPEG/JPG format with a file size ranging from 20 KB to 50 KB.
- Scanned signature in JPEG/JPG format (10 to 20 KB)
- Aadhaar Number is required. In case Aadhaar Number is unavailable, please provide one of the following ID Numbers. (You will need to present the original document at a later stage):
 - · Voter ID Card
 - ° PAN
 - Passport
 - Driving License
 - School/College ID
 - Employer ID (Government/PSU/Private)
- Matriculation (10th) certificate
- Certificate of Disability, if any.

SSC CPO 2024 - Application Fees

The application fee for the SSC CPO exam is Rs. 100, but not everyone is required to make this payment. Certain individuals are exempt from paying the fee. The following is a list of those who qualify for this exemption:

- · Women candidates
- Candidates belonging to Scheduled Castes (SC)
- Candidates belonging to Scheduled Tribes (ST)
- · Ex-Servicemen (ESM)

Additionally, fees can be paid through BHIM UPI, Net Banking, or by using Visa, MasterCard, Maestro, RuPay Credit, or Debit cards. Now that you are aware of every bit of the application process and SSC CPO 2024 Apply Date should we help you ensure your eligibility as well?

SSC CPO 2024 - Eligibility Criteria

The first and crucial step in preparing for any examination involves understanding your eligibility. Therefore, it is essential for you to be acquainted with the eligibility criteria for the CPO exam in 2024. The CPO recruitment exam for 2024 will involve four primary eligibility criteria, outlined as follows:

- Nationality: You must be either a citizen of India or a subject of Nepal or Bhutan.
- · Age Limit (as on 01.08.2024): Your age should fall within the range of 20 and 25 years.
- Educational Qualification: A bachelor's degree from a recognized university or its equivalent is a prerequisite.
- For the post of Sub Inspector in Delhi Police only: Male applicants are required to hold a valid LMV (Motorcycle and Car) driving license on the designated date for Physical Endurance and Measurement Tests to be eligible for the post of Sub Inspector in Delhi Police. Nevertheless, candidates lacking a valid LMV (Motorcycle and Car) driving license are eligible for the post of Sub Inspector in CAPFs only.


