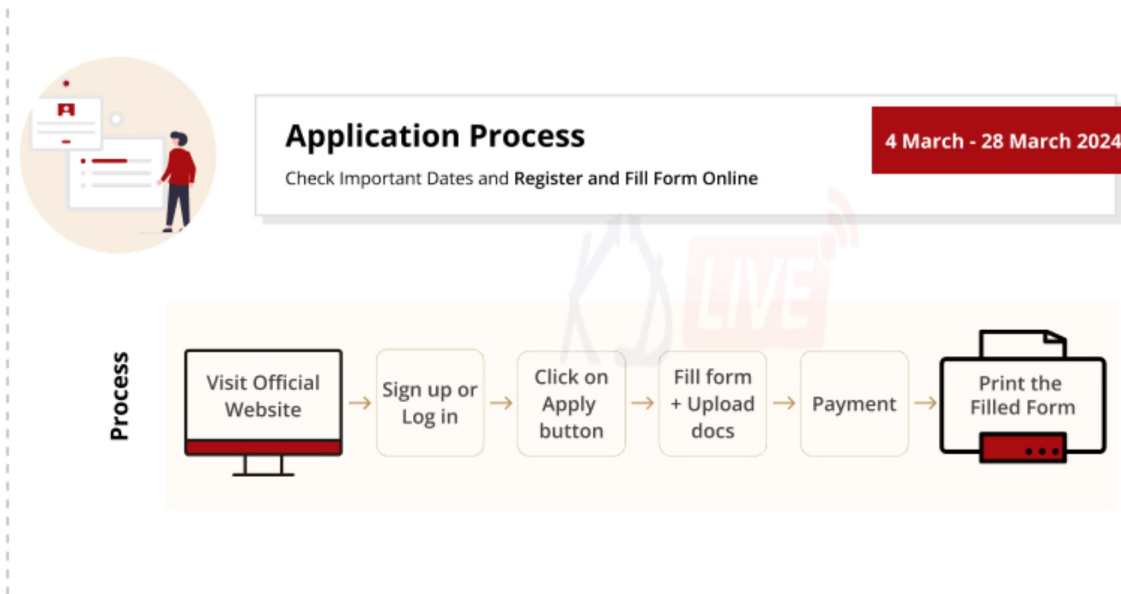

SSC CPO 2024 Documents for Application

When applying for the SSC CPO 2024 exam, ensure that the following necessary documents are readily available:

- Scanned colour passport-size photograph in JPEG/JPG format with a file size ranging from 20 KB to 50 KB.
- Scanned signature in JPEG/JPG format (10 to 20 KB)
- Aadhaar Number is required. In case Aadhaar Number is unavailable, please provide one of the following ID Numbers. (You will need to present the original document at a later stage):
 - Voter ID Card
 - PAN
 - Passport
 - Driving License
 - School/College ID
 - Employer ID (Government/PSU/Private)
- Matriculation (10th) certificate
- Certificate of Disability, if any.

Moreover, make sure to have soft copies of the above-mentioned documents readily available in the sizes specified in your application form.

SSC CPO 2024 Application Fees

The application fee for the SSC CPO 2024 Exam is Rs.100/- (Rupees One Hundred only). Moreover, if you are a woman candidate or belong to Scheduled Castes (SC), Scheduled Tribes (ST), and Ex-servicemen (ESM), then you are exempted from paying the fee.

Additionally, fees can be paid through BHIM UPI, Net Banking, or by using Visa, MasterCard, Maestro, RuPay Credit, or Debit cards. It is important to note that the fee once paid shall not be refunded under any circumstances nor will it be adjusted against any other examination or selection. SSC CPO 2024 - Eligibility Criteria

Curious about your eligibility for the SSC CPO 2024 exam? To apply for positions like Sub-Inspector in Delhi Police, and CAPFs, it's crucial to understand the detailed eligibility criteria. Before diving into exam preparations, make sure you fulfil the specified nationality/citizenship requirements, adhere to the age limits, and hold a graduation degree as outlined for SSC CPO 2024 eligibility requirements.

SSC CPO 2024 Last Date to Apply - Timeline, Process and Fee

- **Nationality:** You must be either a citizen of India or a subject of Nepal or Bhutan.
- **Age Limit:** Your age must be within 20 to 25 years.
- **Educational Qualification:** All positions require at least a bachelor's degree from a recognized university or its equivalent.
- **For the post of Sub Inspector in Delhi Police only:** Male applicants are required to hold a valid LMV (Motorcycle and Car) driving license on the designated date for Physical Endurance and Measurement Tests to be eligible for the post of Sub Inspector in Delhi Police. Nevertheless, candidates lacking a valid LMV (Motorcycle and Car) driving license are eligible for the post of Sub Inspector in CAPFs only.
