Staff Selection Commission

administers the SSC CGL examination. Furthermore, it's important to understand the structure of the SSC CGL examination. The SSC CGL exam consists of two tiers: Tier 1 and Tier 2, both conducted in a computer-based format. The Tier 1 exam is worth 200 marks and lasts for 1 hour. On the other hand, Tier 2 consists of three papers:

- Paper 1 of the SSC CGL Tier 2 exam is worth 450 marks and has a duration of 2 hours 30 minutes.
- Papers 2 and 3 of the SSC CGL Tier 2 exam are each worth 200 marks and have a duration of 2 hours each.


Nationality

- · You must be either a citizen of India or,
- · A subject of Nepal or Bhutan, or
- An individual of Indian origin who has relocated from Pakistan, Burma, Sri Lanka, and East African Countries such
 as Kenya, Uganda, the United Republic of Tanzania (formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire,
 Ethiopia, and Vietnam, with the intention of establishing permanent residence in India.

Remember, if you fall under the last two categories, you are required to possess a certificate of eligibility issued by the Government of India.

Age Limit

• You must fall within the age range of 18 to 32 years. However, various positions might have distinct age criteria.

Educational Qualification

- For the post of Assistant Audit Officer/Assistant Accounts Officer: Bachelor's Degree from a recognized University or Institute.
- For the post of Junior Statistical Officer: A candidate must hold a Bachelor's Degree in any subject from a recognized University or Institute with a minimum of 60% marks in Mathematics at the 12th standard level. Alternatively, a Bachelor's Degree in any subject with Statistics as one of the subjects at the degree level is also acceptable.
- For the post of Statistical Investigator Grade II: A candidate should possess a Bachelor's Degree in any subject with Statistics as one of the subjects from a recognized University or Institute.
- For all other posts: Bachelor's Degree from a recognized University or equivalent.

Assistant Audit Officer/Assistant Accounts Officer

- You need a bachelor's degree from a recognized university or its equivalent.
- Additionally, a Master's degree in Commerce, Business Studies, Business Administration (Finance), Business Economics, or qualifications like Chartered Accountant, Cost & Management Accountant, or Company Secretary are desirable.

Junior Statistical Officer

- A bachelor's degree in any subject is mandatory, with at least 60% marks in mathematics at the 12th standard level.
- Alternatively, a bachelor's degree in any subject with statistics as one of the subjects at the degree level is also acceptable.

Statistical Investigator Grade-II

- A bachelor's degree in any subject with statistics as one of the subjects is required.
- It's necessary to have studied statistics for all three years or all six semesters of your graduation course.

Research Assistant at the National Human Rights Commission (NHRC)

- The essential qualification is a bachelor's degree.
- Desirable qualifications include a minimum of one year of research experience at any recognized university or research institution or a degree in law or human rights from a recognized university.

All other posts

- You need a bachelor's degree from a recognized university or its equivalent.
- If you are in the final year of your graduation, you are still eligible to apply.
