- Successful candidates can access various positions across different pay levels, such as Assistant Audit Officer, Inspector of Income Tax, and Assistant Section Officer.
- Salaries range from Rs. 25,500 to Rs. 1,51,100 depending on the pay level.

- Tier I includes Objective Type and multiple choice questions.
- Moreover, this exam encompasses a total of four subjects.
- Additionally, the exam will comprise 100 questions with a maximum of 200 marks.
- Further, there will be a negative marking of 0.5 marks for each incorrect answer.
- Lastly, the Tier I exam will last for a duration of 1 hour. However, candidates eligible for a scribe as per Para-7.1, 7.2 and 7.3 will receive 20 minutes extra.

- The Tier II exam is segmented into three Papers- I, II, & III.
- Moreover, it is important to highlight that Paper I is compulsory for all posts, Paper II is for candidates who apply for the posts of Junior Statistical Officer (JSO) in the Ministry of Statistics and Programme Implementation and Paper III is for candidates who apply for the posts of Assistant Audit Officer/ Assistant Accounts Officer.
- Lastly, questions will be provided in both English and Hindi languages, except for the English Comprehension section which is obvious.


