

### SSC CGL Economics Syllabus - Topics & Weightage

The official SSC CGL notification does not clearly mention the weightage for individual topics within the SSC CGL Economics Syllabus. However, we can get some insights based on past exam trends. According to previous year's papers, Economics typically features 2-3 questions.

- Overall weightage: The General Awareness section typically holds around 25% weightage in Tier I.
- Focus topics: Based on past exams the following Economics topics carry greater weight in SSC CGL exam:
  - Basic Concepts and Terminologies
  - Banking Committees
  - Inflation and Taxation
  - Miscellaneous

While the weightage isn't explicitly stated, it's necessary to cover the entire SSC CGL Economics syllabus comprehensively. Refer to previous years' question papers to understand the level of detail and types of questions asked. This will help you strategize your preparation and prioritize topics effectively.



- · Moreover, this exam encompasses a total of four subjects.
- Additionally, the exam will comprise 100 questions with a maximum of 200 marks.
- Further, there will be a negative marking of 0.5 marks for each incorrect answer.
- Lastly, the Tier I exam will last for a duration of 1 hour.

- The Tier II exam is segmented into three Papers- I, II, & III.
- Moreover, it is important to highlight that Paper I is compulsory for all posts, Paper II is for candidates who apply for the posts of Junior Statistical Officer (JSO) in the Ministry of Statistics and Programme Implementation and Paper III is for candidates who apply for the posts of Assistant Audit Officer/ Assistant Accounts Officer.
- Lastly, questions will be provided in both English and Hindi languages, except for the English Comprehension section which is obvious.
