Question On Analytical Reasoning

Direction: In the following question, a statement is given followed by three assumptions numbered I, II and III. You have to decide which of the following assumption is/are followed. Statement: Uttar Pradesh Power Corporation Limited has released 1000 posts for Junior Engineers. Aspirants have appealed to the board to introduce written examinations along with an interview for Junior engineers post-recruitment to prevent the selection of incompetent persons. Assumptions: I. Uttar Pradesh Power Corporation Limited used to select candidates without conducting an interview. II. An interview can help to identify competent persons. III. At the higher level, interviews may not be of much use.

Difficulty : Moderate

Average Time : 55 Seconds

Analytical Reasoning Questions Options

1. Only I and II are implicit
2. Only II and III are implicit
3. Only I and III are implicit
4. Only III is implicit
5. None of the above

Analytical Reasoning Questions Solution

The correct answer is **Option 1** i.e. **Only I and II are implicit**

An appeal has been made to 'introduce' a written examination along with an interview. This means that so far interview was not conducted. So, I is implicit. II follows directly from the statement and so it is implicit. However, nothing can be deduced about the mode of selection at higher level. So, III is not implicit.

Hence the correct answer is **Only I and II are implicit**.

1. Try to solve Analytical Reasoning Questions without taking any help from the solutions.
2. Analytical Reasoning Questions require proper usage of concept so firstly read the question thoroughly and then use the right concept.
3. In case you're not able to solve the question in less than 30 seconds in the exam then you should skip the question and move to the next question.
