Difficulty : Moderate

## Analytical Reasoning Questions Options

1. Both assumptions I and II follow
2. Only II follows
3. Only I follows
4. Neither I nor II follows

## Analytical Reasoning Questions Solution

The correct answer is **Option 3** i.e. **Only I follows**

Assumption I is valid because the government's announcement of the new policy implies a need to promote renewable energy sources, which can be seen as a step towards reducing dependence on non-renewable energy sources.

Assumption II is not necessarily valid, as it is possible that the new policy may not lead to a significant increase in the use of renewable energy sources. While the policy aims to promote renewable energy sources, its effectiveness in increasing their use depends on several factors such as the level of implementation and uptake by the public and industry.

Therefore, only assumption I is valid in this case.

Hence, the correct answer is **Only I follows**.
