The correct answer is Option 2 i.e. I is the cause and II is its possible effect

It can be concluded that Statement II is the effect of Statement I. By introducing Turbo UPI, Razorpay aims to simplify the payment process and provide a seamless experience for users. This one-step payment solution eliminates the need for users to be redirected to third-party UPI apps during checkout. This enhanced convenience and integration can potentially encourage more users to adopt UPI as their preferred payment method.

As a result of the increased adoption of UPI facilitated by Razorpay's Turbo UPI, there can be subsequent growth in digital payments. UPI allows for instant and secure bank-to-bank transactions, and its widespread adoption can lead to a reduction in cash transactions. This shift from cash to digital payments can have several positive effects, such as reducing the dependence on physical currency, improving transparency in financial transactions, and increasing overall transaction






