Question On Analytical Reasoning

Statement: The Mid-Day Meal Scheme is one of the most important interventions by Government of India to promote education. On 28 November 2001, the Supreme Court of India passed a mandate stating, 'We direct the State Governments/Union Territories to implement the Mid-Day Meal Scheme by providing every child in every Government and Government assisted Primary School with a prepared mid-day meal." Hence, under this scheme, children of government school receive free and nutritious meals on school days. Assumptions: I. Mid day meals acts as an attractive incentive for parents to send their children to school with the sole hope that their young ones receive at least one plate full of meal for day. II. Mid-day meal schemes helps children enacted to improve socialisation among caste. III. The mid day meal will cost the government more on food rather on the education.

Understanding

Assumptions:

- I. Mid day meals acts as an attractive incentive for parents to send their children to school with the sole hope that their young ones receive at least one plate full of meal for day Implicit (The scheme is introduced for the sake of parents sending their wards to school so that they can get education.)
- II. Mid-day meal schemes helps children enacted to improve socialisation among caste **Implicit** (As students from different backgrounds come to study together).
- III. The mid day meal will cost the government more on food rather on the education **Not implicit** (Not defined as per statement.)

Hence, the correct answer is **Both I and II is** implicit.


