Law Amp Constitution Questions Solution

The correct option is 2 i.e. Shafin Jahan v. Asokan KM and Ors.

- The Supreme Court upheld an individual's right to marry a person of one's own choice as well as the right to choose a religion in this landmark case in the year 2018 by the Honourable Supreme Court by a 3 judge bench decision, popularly known as the Hadiya Case.
- The name Hadiya and the word "Love Jihad" were the two most debated topics Kerala during the 2017-18 period.
- This case revolved around a 24-year-old girl Hadiya born to parents from the Ezhava community in Kerala and were staunch followers of Hinduism. Hadiya converted to Islam and she had gotten married to Shafin Jahan.
- K.M. Asokan, the Respondent, filed a writ of habeas corpus in the Kerala High Court on the ground that her daughter, Hadiya had been forcibly converted to Islam and was deceived into marrying Shafin Jahan.
- Kerala High Court annulled the marriage of Kerala Muslim convert girl Hadiya and Shefin Jahan by an order in 2017. Supreme
 Court set aside the aforesaid order, holding that Kerala High Court could not have used Article 226 to annul the marriage of an
 adult.

In this case, the Supreme Court, relying on the judgement in the case of **Justice KS Puttaswamy and Ors. v. Union of India**, opined that article 21 upholds the right of a person to marry anyone without any constraints such as religion, caste, creed etc. and falls within the sphere of right to privacy.

- In cases like **Shakti Vahini v. Union of India** and **Lata Singh v. State of UP** also, the Supreme Court has upheld the right to marry a person of one's own choice.
- Marriage, plurality and individual choices should be zealously guarded from the state intervention is what has been observed in the judgement.




