Question On Percentage

Monthly income of Ram and Shyam for month of June 2019 is Rs 9205 and Rs 10725 respectively. Also, their overall profit percent in that particular month was 16.67% and 37.5% respectively. Find the difference between monthly expense of both person. Note: Income= Expenditure+Profit

Difficulty : Moderate

Percentage Questions Options

- 1. 590
- 2. 90

Percentage Questions Solution

Let Expenditure for Ram and Shyam be x and y respectively.

Profit (Ram) = 16.67% of x = x/6 (16.67% = 1/6)

Profit (shyam) = 37.5% of y = 3y/8 (37.5% = 3/8)

Income of Ram = x + x/6 = 7x/6

Income of Shyam = y + 3y/8 = 11y/8

Given,

```
7x/6 = 9205
```

Also, 11y/8 =10725

y= 10725 × 8/11 = Rs 7800

Required= Difference between expenditures = x - y = 7890 - 7800 = Rs 90


